ELIGIBILITY

The competition is open to all artists residing in the United States. Work must use clay as the primary material, may not exceed 12x12x12 inches and must weigh less than 10 pounds. The concept of cup may be interpreted freely; however, works that vary appreciably from submitted slides may be rejected, at the discretion of the Gallery Director. Please submit original work completed in the last (2) years.

The exhibition is juried by slides and/or CD. Selected finalists are required to send actual work for exhibition. Necessary assembly and mounting instructions and materials MUST be included with accepted works.

SHIPMENT OF CUPS

All shipping and handling fees to the cup show will be the responsibility of the artist. Please pack the pieces securely, (doubled box, bubble wrap, peanuts) in a sturdy box, carton or crate. The Gallery will follow standard packing procedures for return shipments and will cover return shipping costs to continental US addresses via UPS/ FEDEX. Special handling instructions should be clearly labeled and alternate shipping preferences must be cleared with Gallery staff prior to shipment.

Artists are strongly encouraged to insure work while it is in transit.

Additional shipping details can be discussed upon acceptance into the exhibition. **All shipped work must arrive no later than February 24, 2010.**

IMAGE SPECIFICATIONS

Up to (2) good quality .jpeg images may be submitted per piece. All images must be clearly labeled with the following information: artist's **name**, **title** of the piece, **media**, **size**, **entry number** (from form) and **date**. Image details must correspond with information on entry form. **Include printed image sheet.**

Sales are welcomed. Price lists will be available to the public. Artists must indicate a selling price for insurance purpose.

LIABILITY

The Kent State University School of Art Downtown Gallery will not be held responsible for insuring pieces in transit to/from the exhibition. Upon arrival, pieces will be examined for condition and will be handled with all possible diligence. All work to be shown at the Downtown Gallery will be insured against fire, theft and other hazards at Downtown Gallery while in the possession of the gallery (from the time of receipt through the time of setup and exhibition. Insuring works while in transit is solely the responsibility of the artist. Kent State University cannot be held responsible for damages to work during shipping, and Kent State University insurance will not cover works in transit.

RULES

- All entries, consisting of entry forms, fees and slides, must be postmarked no later than February 2, 2010.
- All works must remain on display for the duration of the exhibition.
- The artist is responsible for shipping charges to the Downtown Gallery.
- Payment of entry fees and submission of images for judging signifies the artist's understanding and acceptance of all rules and conditions of the competition.
